## CPA MEMBERS

Any individual who is a licensed Certified Public Accountant of any state or territory of the United States or the District of Columbia.

**CPA Certified 5 years or more** \$420

**CPA Certified less than 5 years** \$320

**Retired Member** \$120

Any individual who is sixty-five (65) years or older, has retired from the accounting profession, and either is a Certified Public Accountant licensed in any state or territory of the United States or the District of Columbia or was so licensed at any time during the past ten (10) years. Such person affirms that they do not prepare tax returns, perform compilations, perform accounting or auditing work, prepare reviews, work full-time in any capacity—for the IRS, any related accounting function, consultancy, or in any other business or industry, or provide MAS services for a fee in excess of 500 hours in a twelve (12) month period. There is not a restriction of hours worked on a volunteer basis.

**Non-Resident** \$300

A Certified Public Accountant licensed in any state or territory of the United States or the District of Columbia who is domiciled outside the state of Florida.

## AFFILIATE MEMBERS

Any non-CPA individual not currently holding an active or inactive Certified Public Accountant license from any state or territory.

**Accounting and Finance Professionals** \$215

Open to industry-related non-CPA professionals working in a professional accounting or finance position, who are not approved to sit for the CPA exam or Eligible for Exam by the DBPR in Florida, and does not qualify for another category of membership.

**Business and Accounting Educator** \$150

An adjunct or full-time business, data analytics, accounting, or finance professor at a Florida college or university. An adjunct professor does not qualify for this category if jointly working as a CPA or accounting and finance professional.

**Firm Administrator/Office Manager (Non-CPA) Complimentary**

An individual who is designated as a firm administrator or office manager for an entity and said individual does not hold a certificate as a CPA and does not otherwise qualify for a different category of membership.

**CPA Candidate** \$50

A college graduate with a degree in accounting or finance that is currently listed with the Board of Accountancy as 'Eligible for Exam' and does not qualify for another category of membership.

- A maximum of four (4) years in this category.

**Student Complimentary**

An undergraduate student attending a college or university majoring in accounting, finance, data analytics, or a business-related field of study and does not qualify for another category of membership.

- A maximum of five (5) years in this category.
